Anton Shekhovtsov is director of the Centre for Democratic Integrity (Austria), visiting professor at the Department of International Relations of the Central European University (Austria), and associated researcher at the Research Centre for the History of Transformations at the University of Vienna (Austria). He holds a PhD from University College London (UK). He is the author of the books New Radical Right-Wing Parties in European Democracies (2011), Russia and the Western Far Right: Tango Noir (2017), and Russian Political Warfare (2023). Shekhovtsov also published numerous op-eds in international media and several academic articles in the Journal of Democracy, Russian Politics and Law, Europe-Asia Studies, Nationalities Papers, Patterns of Prejudice, and Osteuropa, among others.

**Bàrbara Molas** joined the International Centre for Counter-Terrorism in August 2022 as a research fellow for the Current and Emerging Threats Programme. She received her PhD from York University (2021, Toronto) and is an expert on farright ideology, online radicalisation, and prevention. She has an international consulting background and has worked with intergovernmental organisations, national prosecution services, and big tech companies. Molas is also the co-editor of *Responses to the COVID-19 Pandemic by the Radical Right* (Columbia University Press, 2020) and *The Right and the Radical Right in the Americas* (Rowman & Littlefield, 2021), as well as the author of *Canadian Multiculturalism and the Far Right* (Routledge, 2022).

**Daniel Milo** holds a doctorate in criminal law from Comenius University in Bratislava. His main fields of expertise are hybrid threats, extremism, paramilitary groups, and the use of disinformation by foreign actors. He has published or co-authored several publications on these issues, such as GLOBSEC Trends or analytical reports mapping the links between the Kremlin and far-right political actors. His previous work experience includes the role of coordinator of anti-extremist policies in the Office of the Minister of the Interior of the Slovak Republic, special adviser to the Minister of Justice on extremism, senior research fellow at GLOBSEC, and director of the Centre for Countering Hybrid Threats at Ministry of Interior of the Slovak Republic. He currently teaches a course on the use of hybrid threats in international relations at Comenius University. **Edit Zgut-Przybylska** is an assistant professor in the Institute of Philosophy at the Polish Academy of Sciences and a visiting fellow at CEU Democracy Institute. She received her PhD in sociology, holds an MA in political science, and graduated as a journalist. Her research interest covers informality, populism, and Euroscepticism in the context of democratic backsliding. She is the vice chair of Amnesty International in Hungary and a guest lecturer at the Foreign Service Institute of the US State Department. Edit held a reconstruction fellowship from 2022 to 2023, a rethink. CEE fellowship at GMFUS and a fellowship at Visegrad Insight. She previously worked at the Political Capital Research Institute, and before that, she was a journalist at various media outlets in Hungary.

**Fabian Schmid** is head of the investigative journalism department at the Austrian newspaper DerStandard. His main beats are corruption, extremism, and national security. He has been working for DerStandard since 2013 and was deputy head of the department covering domestic politics and crime. Schmid graduated from the University of Vienna with a major in communication studies.

**Kacper Rekawek**, PhD is a senior research fellow and programme lead (Current and Emerging Threats) at the International Centre for Counter-Terrorism. Prior to joining the ICCT, Kacper worked on issues related to countering terrorism and countering violent extremism while in academia (at C-Rex, Centre for Research on Extremism at the University of Oslo; the Handa Centre for the Study of Terrorism and Political Violence at the University of St. Andrews; SWPS University in Warsaw, and a PhD at Queen's University Belfast), think tanks (the Polish Institute of International Affairs, PISM, and secondments to RUSI London, and Al Ahram Centre, Cairo) and the third sector (Countering Extremism Project in New York/Berlin and GLOBSEC in Bratislava).

**Morgan Finnsiö** is a Swedish investigative journalist focusing on right-wing extremism and far-right politics, and a researcher, analyst, and educator at the Expo Foundation, as well as a contributing editor for the award-winning magazine *Expo*. The Expo Foundation is a Stockholm-based NGO working to strengthen democracy by monitoring anti-democratic movements and organised racism. Morgan's work in recent years includes reports on the Nordic Resistance Movement, transnational right-wing extremism, and antisemitism and Holocaust denial on social media platforms. Most recently he has co-authored a report series

on gaming and extremism, commissioned by the Swedish Agency for Youth and Civil Society.

**Nicolas Hénin** is a consultant and researcher on disinformation and radicalisation. For five years, he has been in charge of following disinformation in France at the EU Disinfo Lab. He attended the 69<sup>th</sup> national session of the Institute of Advanced Studies in National Defence (IHEDN). He is a member of the European Commission's RAN (Radicalisation Awareness Network) Experts Pool, of the FrancoPrev network of the Organisation Internationale de la Francophonie, and a member of the Unesco-Prev Chair in Prevention of Radicalisation. He authored, among others, *Comprendre le terrorisme* (Understanding terrorism), and *La France russe* (Russian France), a book on Russian influence networks in France.

**Ottavia Galuzzi** is a counter-terrorism practitioner and cybersecurity expert focusing on the interconnection of human rights and digital technologies. She has experience working in the private and public sectors, both at the European and international levels, as a cybersecurity and intelligence consultant and adviser. She also has experience in the civil society sector, where she built the knowledge and skills of NGOs to prepare for cyberattacks. She has a master's degree in Cybersecurity, Intelligence and Counter Terrorism from Macquarie University, Sydney, Australia.

**Petrović Predrag** is the research director of the Belgrade Centre for Security Policy, where he has worked since 2006. During his career, he has focused on new and inadequately researched topics such as the privatisation of security, intelligence governance, state capture, and violent extremism. His articles have been published in Serbian and international publications. Publishers Roman and Littlefield included Predrag's case study on the reform of Serbia's security intelligence in a textbook that analyses the security services of over 30 European countries. Predrag obtained a PhD at the Faculty of Political Sciences in Belgrade on intelligence reform in Serbia.

**Przemysław Witkowski** PhD is an assistant professor at Collegium Civitas in Warsaw. He collaborates with the think tank Counter Extremism Project, and Radicalisation Awareness Network, and is a senior research director at the Institute of Social Safety (Warsaw, Poland). He is the author of the books: *Glory* 

to Superman (2017), Laboratory of Violence (2020), The Upcoming Fascism (2023), and The Russian Party (2023).

**Thomas Renard** is the director of the International Centre for Counter-Terrorism (ICCT). His research focuses on (counter-) terrorism and (counter-) radicalisation in Europe. His recent research has focused on the evolution of counter-terrorism policy, on (returning) foreign fighters, on radicalisation in prison and on terrorist recidivism. His latest book is *The Evolution of Counter-Terrorism since 9/11* (Routledge, September 2021). His research has been published in various academic journals and think tanks, and it has informed many policy discussions. He is also regularly interviewed by international media. Previously, he worked at the Egmont Institute, in Brussels, where he remains a senior associate fellow, and was an adjunct professor at the Brussels School of Governance. He holds a PhD from Ghent University and graduated from the George Washington University (MA) and the Université Catholique de Louvain (MA, BA).

Veronika Krátka Špalková studied international relations and European studies at Palacký University Olomouc, where she is currently studying for a doctorate researching propaganda and disinformation. For five years, she worked as an analyst at the European Values Centre for Security Policy, where she focused on projects on propaganda, disinformation, and strategic communication. She teaches at CET Academic Programs in Prague.

**Veronika Víchová** is an analyst at the Centre for an Informed Society, focusing on the topic of disinformation in Central Europe. She holds a master's degree in European Studies and a bachelor's degree in international relations and European studies from Masaryk University in Brno. In 2014, Veronika began her professional journey with the European Values Centre for Security Policy and was actively engaged in research and analysis, with a particular focus on Russian disinformation in Central Europe. She played an instrumental role in the establishment and leadership of the Kremlin Watch programme, a dedicated effort to monitor and counteract disinformation. In 2023, Veronika transitioned to the Centre for an Informed Society as an analyst, leading the Resilience in the Infosphere initiative, focusing on the challenges and solutions related to disinformation.
